1. The lots are 10 x20 and go for \$20 and can be discounted to \$15 . Remembering correctly, they used to be 10 x 10, but most found that too small.
2. You will need to figure out a water/hose source that they can use without issues.
3. You will need rules about fences, etc.
4. People are not always very nice if others don't keep their weeds in control...who will be your "middle person".
5. Who will till your plots and mark them out?
6. Will you have rules for fences, fertilizers, pesticides?
7. We (FFA) have no interest in doing any more gardens.

The School District has no role other than providing the land. The small income that is made on the land is used to pay our students who manage this operation, purchase hoses, tools as needed, and stakes for laying out the plots.

They generally fill all the spots so probably a need.

# CITY OF LAKE GENEVA EVENT PERMIT APPLICATION

Applications must be submitted **AT LEAST 10 WEEKS** prior to the proposed event date(s).

### Section I - What type of Permit(s) will your event require?

- Parade Permit.** Required for any parade on public property.
  - Map or description of the requested route to be traveled.
- Public Assembly Permit.** Required for any public gathering on public property. No fee required.
- Street Use Permit.** Required for any event using a public street. Per Sec. 62-243 of the municipal code, this application must include the following attachments:
  - Certificate of Comprehensive General Liability Insurance with the City, its employees and agents as additional insured with coverage for contractual liability with minimum limits of \$500,000 per occurrence for bodily injury and property damage limits of \$250,000 per occurrence.
  - Petition signed by more than half of the residential dwelling units and/or commercial units residing along that portion of the street designated for the proposed use or whose property is denied access by virtue of the granting of the permit.
- Parking Stall Bag Request.** Required for reserving the use of any City parking stall in conjunction of with an event.
- Park Reservation Permit.** Required for reserving the use of a park facility or shelter.
  - Brunk Pavilion.** Requires rental of Flat Iron Park. Additional rental fees apply.
- Beach Reservation Permit.** Required for reserving the use of the beach.
